2) **Eligibility:-**


Scholarship will be awarded to:-

- i. Needy and highly talented students who are otherwise unable to continue their studies.
  - ii. Minimum CGPA for applying PEP Foundation Scholarships is **2.50 /4.00** in semester system **or 60%** marks in annual examination.
  - iii. Only 1<sup>st</sup> semester morning can apply.
  - iv. The students of M.Phil are not eligible for apply.
  - v. Those, already in receipt of any Scholarship/Financial Assistance/ or engaged in public/ private sector or in any project need not to apply.
  - vi. Declared monthly income of Parents (from all sources) is equal to or less than PKR 30,000/-
- 3) Applicants have to appear before the scholarship awarding committee according to the schedule and venue notified later on.
- 4) The application form is available at photocopy shop outside the university, and on website of GCWUF.
- 5) Ensure submission of applications along with following documents in SFAO upto **December 14, 2021** positively.
